- Members were informed that the Development and approval of the school-level Title 1 Parent and Family Engagement Policy (PFEP) and School Parent Compact would be shared with members by the following meeting.
- The principal also spoke about the following:
 - SSC operates under the Greene Act.
 - Meetings are public; agendas posted 72 hours in advance in a visible location at the school.
 - Agenda must include date, time, location, items to be addressed, and note if action is required.
 - Council may only act on items properly included on the posted agenda.
 - o Actions on items not listed as actions items are invalid.
 - Non-agenda items may only be considered in unusual circumstances with unanimous vote.
 - Council must determine if the item is urgent and was unknown when the agenda was posted.
 - Members were informed that Rockdale VAPA magnet uses the District bylaws for SSC.
 - Reviewed Officer roles and responsibilities for Chairperson, Vice-Chairperson, Secretary, and Parliamentarian.
 - Reviewed the parliamentary basic rules of procedures and processes for conducting business, steps to handle a motion, and uniform complaint procedures.

- Reviewed 2025-2026 SPSA & Budget Allocation of Additional Funds in 7S046 Allocation of Additional Funds in 7E046
 - Purpose of Federal Title 1 Resources:
 - Title I Parent Involvement (2025–26): 7E046 \$1,010 allocated (7S046 CE-NCLB T1) \$69,745.
 - California Dashboard
 - Student population
 - English Language Arts
 - Mathematics
 - Chronic Absenteeism
 - Conditions & Climate
 - socioeconomic disadvantage noted, no Title III funds.
 - Equity Report focus on Latino/Latinx achievement; declines in reading, math, and chronic absenteeism (down 3%).
 - Target groups: Hispanic and socioeconomically disadvantaged students; conditions & climate include suspension rates.
 - Stefani Willaims, Principal reviewed the survey results (Spring 2025 Survey):
 - Priority needs: Instructional Aides, Supervision Aides, additional
 - Arts support, PSW/Psychologist.
 - Prop 8 expected to help fund Arts
 - Members were also informed about Title I restricted additional allocations for 2025-26 for each of the programs 7E046/7S046
- Members discussed holding SSC meetings virtually/Hybrid.
 - A motion to hold meetings virtually was made by Heidy Arrivillaga, Teacher (Parliamentarian).
 - The motion was seconded by Nijolitsa Vagena, Teacher.
 - The results were nine in favor, none opposed, and no abstentions.
 - The motion carried.
